### **PRIZE WINNERS OF OCTOBER 2021/ APRIL 2022 EXAMINATIONS**

- **1st & 2nd Scholarships awarded by the I.C.L.E.** (as per Rule No.52, 53/1 (a) (b) & 53/2 of the Council)
52. Scholarships and prizes shall be awarded by the Council from moneys vested in the Council for such value, and subject to such conditions, as the Council may by resolution determine.
53. (1) No student shall be eligible for a scholarship awarded on the result of any examination
- (a) unless he obtains not less than 60 percent, of the aggregate maximum number of marks in all the subjects for that examination and not less than 45 percent, of the maximum number of marks in each of the subject for that examination, and
- (b) unless, in the case of scholarships awarded in respect of the Preliminary examination, the Intermediate examination and the Final examination, he was not more than 24,25 and 27 years of age, respectively, on the first day of such examination.
- (2) No student shall be eligible for a prize awarded for any subject, unless he obtains not less than 75 percent, of the maximum number of marks for that subject and passes the examination of which that subject is a part and is not more than the age specified in (1) above.
